emBARKERS Hound Lounge Information and Policies

The purpose of the emBARKERS Hound Lounge is to provide a safe, fun and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules and regulations:

Age: All dogs must be at least 16 weeks of age or older.

Sex: All dogs 6 months of age or older must be spayed or neutered.

Vaccinations: Owners must submit written documentation that their dogs have been vaccinated against canine parvovirus, canine distemper, infectious canine hepatitis, Bordetella (kennel cough), and, when necessary, Leptospirosis.

Health: All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition. If they have had a communicable condition, owners will need to provide a veterinarian certification of health to be admitted or readmitted.

These requirements and suggestions are not a guarantee against infection, but an attempt to minimize the chances of contagion.

emBARKERS takes the safety of all dogs in our care extremely seriously and we appreciate your compliance and understanding with our requirements.

Behaviour: All dogs must be non-aggressive and not food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behaviour towards any person or any other dogs.

Refunds: If emBARKERS decides your dog is unable to continue attending daycare, the unused portion of any session pass purchased will be refunded.

Days and Hours: The emBARKERS Hound Lounge dog daycare is open from 7.45am to 6.30pm Monday to Friday.

Late fees: If you pick up your dog within the first half hour after closing, you will be charged an extra \$15 to be paid immediately.

Any later than that will incur a \$30 charge, also to be paid immediately.

Reservations/No Show Policy: Reservations are required. If you want to cancel a reservation, you must do so before 10am of the day prior or you will be charged full price.



Owner Liability Waiver and Health Certification

Owner Agreement

I, _____, hereby certify that my dog _____
Is in good health and has not been ill with any communicable condition in the last 30 days. I further certify that my dog has not harmed or shown aggressive or threatening behaviour towards any person or any other dog. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog while my dog is attending the emBARKERS Hound Lounge Dog Daycare ("centre").
2. I further understand and agree that the emBARKERS Hound Lounge and its staff and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's attendance and participation at the centre.
3. I understand and agree that dogs can sometimes receive minor cuts and scratches at the daycare and any problems that develop with my dog will be treated as deemed best by staff and volunteers of the centre, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
4. I understand that if my dog exhibits any signs or symptoms of being unwell they will immediately be put in a comfortable, isolated area until I, or an authorised person can retrieve them. Dogs in the isolation ward will be cared for with fluids, toilet breaks, and (when appropriate) chew toys, but will not be allowed to have any contact with other dogs.
5. I authorise emergency medical care to be provided by the above-named veterinarian, or an appropriate alternate to be determined by emBARKERS in the event that my regular veterinarian is not available or that closer care is required. I will reimburse emBARKERS for any charges related to emergency care.

Y: I authorise emBARKERS to administer or seek first aid and resuscitative care as determined appropriate by emBARKERS and I agree to indemnify and hold harmless emBARKERS for all and any results thereof.

N: I DO NOT authorise emBARKERS to administer or seek first aid and resuscitative care as determined appropriate by emBARKERS and I agree to indemnify and hold harmless emBARKERS for all and any results thereof.
